## *President Barchi to be the Guest Speaker at Spring Luncheon*



*Dr. Robert L. Barchi, the 20th President of Rutgers University will be the guest speaker at our Spring Luncheon on May 16, 2013.*

Dr. Barchi is a renowned neuroscientist, respected educator and academic innovator and successful fundraiser. Dr. Barchi began serving as president on Sept. 1, 2012 coming to Rutgers from Thomas

Jefferson University in Philadelphia where he served as president since 2004. Previously, he served as provost of the University of Pennsylvania, where he was Penn's chief academic officer with oversight of the university's schools, athletics and academic programs, and students and faculty.

Dr. Barchi was born in Philadelphia and lived in Westfield, NJ until his high school years. He received both his B.S and M.S. degrees from Georgetown University and his Ph.D. and M.D. degrees from the University of Pennsylvania. He is board certified as a specialist in neurology.

Dr. Barchi began his career as a faculty member at the University of Pennsylvania in 1972. He became the David Mahoney Professor of Neurological Sciences within a decade. He was named the Fairhill Professor in 2002, a position that he still holds in emeritus status. He was named provost of the University of Pennsylvania in 1999 and served there until 2004 when he took over the presidency of Thomas Jefferson University.

Dr. Barchi has headed a research laboratory that for 30 years was continuously awarded National Institutes of Health grant funding. He is widely respected for his pioneering work on the structure and function of voltage-gated ion channels and on the role those important molecules play on human diseases.

In 1993, he was elected to the Institute of Medicine of the National Academy of Sciences. He has also been elected to the American Society for Clinical Investigation and the Association of American Physicians and was named a fellow of the American Association for the Advancement of Science, the American Neurological Association and the American Academy of Neurology.

Since taking over the leadership at Rutgers, Dr. Barchi has been overseeing preparation for integrating into Rutgers most units of the University of Medicine and Dentistry of New Jersey. He has begun work on a university strategic plan and was part of a statewide coalition urging voter support of a \$750 million bond act for higher education construction which was approved in November. President Barchi was also highly involved in the discussions resulting in the New Brunswick Intercollegiate Athletic teams receiving an invitation to join the Big Ten Conference.

Dr. Barchi is married to Francis Harper Barchi, a tenure-track faculty member of the Rutgers School of Social Work. The Barchis have four adult children and a dog and enjoy spending their leisure time at their home in coastal Maine. They are avid boaters and hikers. Dr. Barchi also is an expert in the history and mechanical development of clocks and watches. In addition to collecting and conserving timepieces from the 17th and 18th centuries, he designs and constructs his own precision clocks in his basement machine shop.

## **Rutgers Boards Approve Restructuring Act and UMDNJ Integration**

On November 19, 2012 the Rutgers Boards of Governors and Trustees, exercising their unique responsibility to consent to fundamental changes to the institution under the covenant Rutgers signed with the State in 1956, voted unanimously to approve the changes outlined in the New Jersey Medical and Health Sciences Education Restructuring Act.

This historic act, which was signed by Governor Christie in August and will take effect July 1, 2013, transfers to Rutgers nearly all of the schools, institutes, and centers of the University of Medicine and Dentistry of New Jersey. (The exceptions are the School of Osteopathic Medicine in Stratford, which is being integrated into Rowan University, and University Hospital in Newark, which will become a

separate non-profit entity but will remain the primary teaching hospital for the New Jersey Medical School, School of Nursing, and New Jersey Dental School.) Further, the act provides greater autonomy for the Rutgers-Camden Campus, creates advisory boards for each Rutgers campus, and establishes formal collaboration between Rutgers-Camden and Rowan in the area of health sciences.



## CAMPUS NEWS

### CHANGES ARE ALL AROUND US

How long has it been since you last visited the Livingston Campus or downtown New Brunswick? If it has been more than a year, you may not even recognize the Livingston Campus and you might not find what you are looking for in New Brunswick.

The newest project at Livingston includes new four bedroom apartment style living units with a shared kitchen and living room and two shared bathrooms. These units are found in mid-rise buildings located at the intersection of Joyce Kilmer Road and Rockefeller Road. The apartments opened up for students to move in in fall of 2012. In addition to the apartments, there are street level spaces in each building which will soon accommodate retail establishments such as a café, bakery, convenience store and a restaurant. This college town also includes an already open movie theatre which shows currently released movies at night and is utilized as a large lecture hall during the day. Located across the street from the new Student Center and Dining Hall, the new college town completes a long in coming makeover of the Livingston Campus making the campus the new campus of choice to live on.

If you enter the Livingston Campus from Metlars Lane you will come upon the new “space age” looking addition to the Rutgers School of Businesses located on Avenue D and Rockefeller Road adjacent to the Levin Building. Anticipated occupancy of this building is fall 2013.

All of this construction is in addition to the solar panel farm located across the street from the Recreation Center. Livingston used to be known for its vast parking lots. A lot of those lots have been lost due to the new buildings, but those losses are well worth the gains the Campus has benefited from.

Future construction will include a renovation of the Louis Brown Athletic Center.

If you are going to New Brunswick looking for the Rutgers Bookstore, don't go to Albany Street by the Ferren Deck. The bookstore has moved into the new Gateway Transit Village Building on the corner of Somerset Street and Easton Avenue. The bookstore is now run by Barnes and Noble. It features a floor dedicated to textbooks, academic reference materials and school supplies, a campus “living room” and a children's book corner providing space for entertainment and educational programs, a Scarlet Knight Shop with RU merchandise and a main level providing general interest books, a gift shop, a large café used for book signings, poetry readings, university and community lectures, musical performances and other


cultural events. The entrance for the bookstore can be found on Somerset Street at the end of College Avenue.

Besides the bookstore, the Gateway Transit Village Building also includes residential units, office space and a parking garage. The University Press has relocated to office space in the building and is located on top of the bookstore.

Downtown New Brunswick also now houses a Fresh Grocer grocery store located in the Robert Wood Johnson Fitness and Wellness Plaza at 100 Kirkpatrick St. The parking garage is located off of Joyce Kilmer Ave and Kirkpatrick Street. The store is a full service store offering a variety of prepared foods, made to order subs, coffee bar, brick oven pizza and salad bar, bakery, fresh seafood and meat departments and a catering department. It also sells wine and beer. The lobby offers a few tables for enjoying a meal. The store is open 24 hours, 7 days a week and offers 3 hours of free parking validation with a \$10 minimum purchase. The store also offers free shuttle service within New Brunswick with a \$50 order. Located across the street from the train station and just a short walk from College Avenue, it is a convenient place to shop both for students and commuters coming home on the train.

Rutgers women's basketball coach, C. Vivian Stringer, received her 900th career victory on Tuesday, February 26, in a win against South Florida 65-56 at the Louis Brown Athletic Center. Coach Stringer reached the milestone shared by North Carolina's Sylvia Hatchell and retirees Jody Conradt and Pat Summitt on the women's side and Mike Kryzewski, Bob Knight and Jim Boeheim on the men's side. The Silver Knights extend their congratulations to Coach Stringer on this milestone accomplishment.

## TWENTY EIGHT EARN BIG EAST ACADEMIC HONORS

The conference office announced that twenty-eight student athletes from the Rutgers football team were named to the Big East All-Academic Football Team. The number of honorees is up two from last season.

Senior Scott Vallone finished his career as a four-time Big East All-Academic team member. Earning distinction for the third time were seniors Brandon Jones, Duron Harmon, and Matt McBride and junior Logan Ryan.

Eleven student-athletes were honored for the second time, including junior Taj Alexander, junior Betime Bujari, senior Paul Carrezola, junior Brandon Coleman, junior Chas Dodd, senior Justin Doerner, senior Robert Jones, junior David Milewski, senior Quron Pratt, senior Lorenzo Waters, and senior Timothy Wright. A total of 12 were listed for the first time.

The 207 members selected from across the league were nominated by their respective institutions. To be nominated, a player must have a cumulative grade-point index of at least 3.0 and completed a minimum of two semesters of academic work.

## RUTGERS JOINS AN ELITE CONSORTIUM OF TOP-NOTCH RESEARCH UNIVERSITIES

Fans of Scarlet Knights sports are understandably thrilled about Rutgers' new membership in the Big Ten Conference. But just as exciting, and equally important, is the University's joining the Committee on Institutional Cooperation (CIC) the nation's premier consortium of top-notch research universities that includes the members of the Big Ten and the University of Chicago. "Most of the schools in the consortium are, like Rutgers, large

state universities that serve a similar mission," said Robert L. Barchi, the President of Rutgers. "This is where Rutgers belongs. The CIC is committed to advancing its members' academic missions, leveraging campus resources, sharing expertise, and expanding academic and research opportunities for students and faculty."

The addition of Rutgers, along with the University of Maryland-College Park, the other new member of the Big Ten, increases the CIC membership to 15 institutions, which will collectively engage in \$9.3 billion in funded research each year and will add another eight million library volumes and more than 5,600 faculty to the consortium. The universities are leaders in cutting-edge, collaborative research projects in areas as diverse as biotechnology, transportation, cybersecurity, and food safety. Rutgers will become a member of the consortium on July 1, 2013.

## A LITTLE-KNOWN BENEFIT FOR AGING VETERANS

There is a Department of Veterans Affairs benefit called the AID AND ATTENDANCE AND HOUSEHOLD IMPROVED PENSION benefit, known as A&A, which can cover the costs of caregivers in the home (including sons and daughters who are paid to be caregivers, though not spouses) or be used for assisted living or nursing home. The benefit is approximately up to \$2,019 monthly for veteran and spouse or \$1,094 for the widow of a veteran. To qualify, a veteran need not have suffered a service injury. He/she only had to have clocked at least one day of his/her 90-day minimum service during a time of war and need caregiving for activities of daily living. There is also an income cap involved. 

# Architectural Drawing of the Future Entrance to the Retiree Faculty and Staff Center

The picture at right is the architectural drawing of the future entrance to the Retiree Faculty & Staff Center to be located at the Administrative Services Building II on Route 1 South in New Brunswick (adjacent to Sears). The grand opening of the Center is projected for Summer 2013.

Rutgers has initiated a university-wide Faculty and Staff Association (RFSA), which will serve as an "umbrella" organization for existing retiree groups such as AAUP Emeriti Assembly, the Retired Faculty Association, and the Silver Knights, the Staff Retiree Organization. The University has committed personnel, space, and assets to ensure an effective organization to serve Rutgers retirees. Vivian Fernandez, University Vice President for Faculty and Staff Resources, has assumed responsibility for facilitating the details of this endeavor.

A university-wide Faculty and Staff Advisory Council has been appointed to assist



the administration in creating the strongest possible program for retired faculty and staff from Camden, Newark, and New Brunswick. Gus W. Friedrich, Dean Emeritus of the School of Communication and Information, has been appointed chairperson of the Council. The Council currently works in four task groups: Administration/Operations (overall coordination), Programming (developing & clearing house

for all events, programs & amenities and volunteer opportunities for retirees), Communications (developing the database and website), and Fundraising/Retiree Center (developing plans for fundraising and sites).

We will continue to keep you informed on the progress of the Center and the Council.
